

Manhari Rural Municipality Office of the Rural Municipal Executive Rajaiya <u>Invitation for Bids</u> (First date of Publication: - 2076/02/15)

1. The *Manhari Rural Municipality, Rajaiya acting on behalf of the Government of Nepal, invites sealed bids from eligible bidders for the following works under listed below.*

2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in Public Procurement Acts and Regulation and is open to all eligible bidders.

3. Interested eligible bidders may obtain further information from office of *Manhari Rural Municipality, Rajaiya* and inspect the Bidding Documents at the address given below during office hours or may visit E-procurement section of PPMO's Web Site http://www.ppmo.gov.np/egp.

4.Qualification requirements include minimum required average annual turnover, experience in similar works, minimum number of essential equipment, qualification and experience of key site managers and technical personnel, minimum amount of liquid assets and/ or credit facilities as specified in the bidding documents. Qualification requirement details can be obtained from E-procurement section of PPMO's Web Site http://www.ppmo.gov.np/egp.

5. A complete set of Bidding Documents may be purchased from the office by eligible Bidders on the submission of a written application, along with the attested copy of company/firm registration certificate, latest tax clearance certificate and upon payment of a nonrefundable fee as mentioned in the table below within office hours on and before 2076/03/12. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission fromPPMO's Web Site www.bolpatra.gov.np/egp Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Main Reserve account as specified below and the scanned copy (.pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Bids must be delivered to the **Manhari Rural Municipality, Rajaiya** on or before 12:00 hrs of 31st (2076/03/13) day of notice publication. Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web Site <u>http://www.ppmo.gov.np/egp</u>. as specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened physically and electronically 14:00 hrs of same date in the presence of the bidders' representatives who choose to attend in person at **Manhari rural Municipality, Rajaiya** on the same day after bid submission deadline.

7. The bid security guarantee shall confirm to the standard format as specified in the bid document and that issued only by the commercial bank approved by Nepal Rastraya Bank shall be accepted by the employer.

8. Bids shall be valid for a period of 90 days after the deadline for bid submission date. Bid security shall remain valid up to 120 days after the deadline for bid submission.

9. Pre-bid meeting will be held in the office of *Manhari Rural Municipality, Rajaiya* at **14:00** hrs on 20th day (2076/03/03) of notice publication. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.

10. The employer reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.

11. If the specified date for pre-bid meeting, last date of bid document purchasing and submission/opening falls on a Government holiday then the same time on the next working day shall be considered for such events. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing. In such case the validity of bid security shall be considered from already specified last date for bid submission.

12. Bidders are strongly advised to visit the site prior to bidding, and No intimidation, collusion and cartelling during & after bidding process shall be punishable by law. Details of Works
